The papers selected for the journal will undergo the regular review process.

The papers should be written in English or Serbian. Abstracts and full papers should be sent by e-mail to: ns2020@eknfak.ni.ac.rs. Received manuscripts will be reviewed by anonymous referees and the authors will be notified of the decision by 20 September 2020.
