- **The academic journals Economic Themes and Facta Universitatis: Series Economics and Organization.** We are pleased to announce that selected papers, nominated by reviewers and presented at the Conference, will be published in the journals Economic Themes (<http://www.degruyter.com/view/j/ethemes>, <http://www.economic-themes.com/>) or Facta Universitatis: Series Economics and Organization (<http://casopisi.junis.ni.ac.rs/index.php/FUEconOrg>). The papers submitted for the journals will undergo the regular review process.

The papers should be written in **English or Serbian**. Abstracts and full papers should be sent by e-mail to: ns2022@eknfak.ni.ac.rs. Received papers will be reviewed by anonymous reviewers, and the authors will be notified of the decision by 20 September 2022.
